

Program Update / Walt Woron, KJ4HE

Whether you want to earn Worked All States, DXCC, or any of the many other ham radio awards out there, you will probably need to know how to go about collecting QSL cards or Logbook of the World confirmations. What better way to learn the finer points than from a couple of veteran DX chasers, **Bill Barr**, **N4NX**, and NFARL President **Neil Foster**, **N4FN**, at our August meeting.

Bill Barr (at left), who is also a NFARL member, has been licensed since 1956. His




passion is working DX and he is at the top of the DXCC Honor Roll with 357 countries confirmed. He has nine-band DXCC and is a member of the A1 Operators Club. He has earned many other awards, including five-band Worked All States, seven-band Worked All Zones, and the USA-CA All Counties award.

Bill is an avid traveler, having visited more than 70 countries and has operated from nine of them. Bill is also very active in the Southeastern DX Club. He operates all bands and modes but says his favorite mode is CW. Bill is also an official

ARRL QSL field checker and can answer any questions you might have about the field-checking process.

First licensed in 1960, NFARL President Neil Foster, N4FN, (at right) has been active in the Atlanta ham community for many years having served as president of the Quarter Century Wireless Association, Atlanta Radio Club (twice), the Southeastern DX Club, as well as having held other offices in those clubs.

An active DXer, Neil has 344 countries confirmed and nine DXCCs. Of all the ham radio awards he has achieved, he says he is proudest of the Arabian Knights Award (number 568 in the world) and the Royal Jordanian Silver Award (number 191 in




the world) from the Arabian Amateur Radio League, issued by and personally signed by **King Hussein of Jordan, JY1**, as well as The Commonwealth DX Award (number 332 in the world) issued by the Radio Society of Great Britain. Neil also holds the British Class A license, call sign G0NBJ (his original call was G5DKW), having taken the British RAE years ago. He has operated from 13 DXCC entities, and he is a member of the DXCC Honor Roll.


Last go 'round we learned the importance of avoiding overload. Some kind of attenuation is key, especially for these little hunts. If nothing else, as we learned from **Jim Stafford**, **W4QO**, some aluminum foil to act as a shield on the rubber duck one can work wonders. And remember, you can use your body as an attenuator as well.


The other trick that we used last time as folks got really close was to listen for the third harmonic of the "fox." The third harmonic of 145.565 MHz is 436.695 MHz. For those of you with dual-band radios, you might want to program this frequency into memory as well.

The "fox" will be in place by 7:00 PM. We need to be done by 7:30 PM so as not to hold up the meeting. So bring your gear and let's find that hidden transmitter!

Ham Antennas May See Light of Day in HOA Neighborhoods

A bill recently introduced in the U.S. House of Representatives opens the door for ham antennas in neighborhoods that currently prohibit them. This bill would extend the exemptions already provided for satellite and off-the-air TV antennas to ham radio antennas. HR 4969, also known as the Amateur Radio Parity Act of 2014, calls for new FCC rules that would prohibit "application to amateur service communications of any private land use restriction, including a restrictive covenant ... that fails to reasonably accommodate such communications."



Imagine not having to hide antennas in your attic, disguise them in the trees or make them look like a flag pole? Or, how about a modest tower or mast to enhance your DX communications or provide a better location for your VHF/UHF antennas? All this will become reality if HR 4969 becomes law.

NFARL encourages all members and friends to support this bill by contacting their congressional representative. The key messages:

- 1) Amateur radio is a vital service to our communities and major public service agencies;
- Amateur radio operators seek the same accommodations already provided for satellite and TV antennas;
- 3) Ask your representation to a) support HR 4969 and b) more importantly, sign on as a co-sponsor of the bill.


Seventeen representatives have signed on as co-sponsors of the bill, but many more are needed to ensure success. All the information you need to prepare a letter or e-mail to your representative can be found here.

Skywarn Spotter Class Being Offered

The DeKalb County Emergency Management Agency in conjunction with the National Weather Service will offer a free Skywarn storm spotter class from 7:00 PM to 9:00 PM on September 23. The class will be held at DeKalb County Fire Rescue Headquarters, 1950 West Exchange Place, Tucker 30084.

Skywarn storm spotters are a valuable part of the first line of defense in the threat of

severe weather. Storm spotters are trained to identify and report weather conditions during severe weather. This effort provides on-the-ground data that forecasters can use to issue watches and warnings for local communities.

Amateur radio operators are encouraged to take this class.


The Skywarn storm spotter training involves training in basics of thunderstorm development; fundamentals of storm structure; identifying potential severe weather features; information to report to the National Weather Service; and basic severe weather safety.
